REQUEST DETAILS:

"I'm contacting to you to find out the number of a) arrests b) police cautions at the following venue or its surrounds connected to sporting events at Portman Road (Ipswich Town Football Club, IP1 2DA) broken down by year for 2016, 2015, 2014, 2013 and 2012.

I appreciate you may be unable to say conclusively if an arrest or caution was specifically related to a sporting event. In this case are you able to provide dates of any arrests or cautions which I will be able to use to cross reference sporting fixtures?"

RESPONSE:

Suffolk Constabulary has considered your request for information and our response is below.

This response is correct as of 5 January 2017

A search has been completed of the Constabulary's crime system for all offences recorded as being committed within the vicinity of Ipswich Town Football Club, where there is an associated custody record.

The tables below confirm the total number of offences recorded (where an arrest was made) within the vicinity of the football ground, including the offence description and outcome. Please note that the offences do not necessarily relate to the sporting event itself as many of the arrests were made on non-match days.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.
