I write in connection with your request for information received by Suffolk Constabulary on the 23 January 2018 in which you sought access to the following information:

“Under the Freedom of Information Act could you please give me a breakdown of the number of reports of domestic abuse by year by year for the past five years (Q1-Q4 inc) up to January 2018, including:

2017/18, 2016/17, 2015/16, 2014/15, 2013/14 broken down by the gender of the perpetrator/accused?

And, if possible, a break down by the age of the alleged perpetrator/accused?”

Response to your Request

The response provided below is correct as of 30 January 2018

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s crime system for all Domestic offences recorded during the 2013/14 – 2017/18 financial years.

The information provided in the attached spreadsheet confirms the total number of offences recorded, by suspect gender and age, where recorded.

Please note that due to a change in crime recording system during October 2015, the information has been presented in two separate tables. The information is based on the financial year in which the offence was recorded by the Constabulary, as opposed to when the offences actually occurred.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
