I write in connection with your request for information received by Norfolk and Suffolk Constabularies on the 15 February 2018 in which you sought access to the following information:

1. *"Please disclose how many reports of sexual assault against a female the force has received in the past 12 months where a home delivery driver has been implicated as the offender. (For example the MO notes or occupation of suspect indicate the offender is a delivery driver);"*
2. *Please provide a breakdown showing numbers for each type of sexual assault;*
3. *Please disclose how many reports of harassment against a female the force has received in the last 12 months where a home delivery driver has been implicated as the offender."*

Response to your Request

The response provided below is correct as of 27 February 2018

Norfolk and Suffolk Constabularies have considered your request for information and our response is below.

A search has been completed of the Constabularies crime system for all sexual and harassment offences recorded against females during the time frame February 2017 – January 2018.

1. The Constabularies crime system does not have an option within the occupation field of 'delivery driver'. There is the option to sort offences by occupation of 'driver', but this will provide information excessive to the requests requirements.

A manual search has therefore been undertaken to extract all offences with 'driver' as an occupation and the terms 'deliver', 'royal mail', 'hermes', 'dpd', 'ups', 'parcel', 'courier' within the crime text. Each crime was then reviewed to ensure relevancy to the request.

The information extracted is provided in the table below, noting that the information is only based on offences that specifically mention these terms in the crime and have the occupation recorded as 'driver'.

3. Using the same search terms as above, the Constabulary located no harassment offences where the victim was female.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.
