I write in connection with your request for information received by Suffolk Constabulary on the 20 February 2018 in which you sought access to the following information:

“This request relates to the following offences under the Misuse of Drugs Act 1971:

- i. Possession of cannabis*
- ii. Possession of cannabis with intent to supply*
- iii. Supply of cannabis*
- iv. Cultivation of cannabis*

For each of these offences, separately, please supply the following data for the periods: 2016/2017, 2015/2016, 2014/2015, 2013/2014, 2012/2013, 2011/2012, 2010/ 2011, 2009/2010, 2008/2009, 2007/2008, 2006/2007

- The total number of warnings issued to individuals aged over 18*
- The total number of warnings issued to individuals aged under 18*
- The total number of fines given to individuals aged over 18*
- The total number of fines given to individuals aged under 18*
- The total number of cautions issued to individuals aged over 18*
- The total number of cautions issued to individuals aged under 18*
- The total number of arrests of individuals aged over 18*
- The total number of arrests of individuals aged under 18*
- The total number of charges pressed against individuals aged over 18*
- The total number of charges pressed against individuals aged under 18*
- The total number of prosecutions brought against individuals aged over 18*
- The total number of prosecutions brought against individuals aged under 18*
- The total number of convictions secured of individuals aged over 18*
- The total number of convictions secured of individuals aged under 18*
- The total number of community disposals given to individuals aged over 18*
- The total number of community disposals given to individuals aged under 18.”*

Response to your Request

The response provided below is correct as of 7 March 2018

Suffolk Constabulary has considered your request for information and the response is below.



In relation to your request for information and in accordance with Section 17 of the Freedom of Information Act 2000 (FOIA), this response serves as a formal notification of refusal for your request. Suffolk Constabulary does not hold, for the purposes of FOIA, the information you require in a retrievable format.

It is estimated that to attempt to retrieve all of the information you require would take a considerable amount of retrieval time, which would exceed 18 hours. This would exceed the appropriate limit for dealing with Freedom of Information requests, in terms of costs and therefore Section 12(1) of the Freedom of Information Act 2000 applies.

Suffolk Constabulary changed crime and custody recorded system from 19 October 2015, prior to which time the arrest only broke drug offences down by drug type. Information held on the legacy system (NSPIS) classifies drug offences under an overarching category. The only way to establish the number that relate to cannabis would be to manually review many thousands of custody records, which would well exceed the maximum 18 hours permitted under FOI.

Section 12(1) of the Freedom of Information Act 2000 states that a Public Authority is not obliged to: *"...comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit."* The Freedom of Information (Appropriate Limit and Fees) Regulations, defines the 'appropriate limit' for the Suffolk Constabulary as £450 and specifies that this sum equates to 18 hours work at a standard rate of £25 per hour.

In accordance with Section 17(5) of the Freedom of Information Act 2000, this letter serves as a refusal notice for this part of your request.

By requesting *all* information your request is too broad to be complied with within the £450 limit imposed on Freedom of Information requests.

Although excess cost removes the Force's obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

A search has been completed of the Constabulary's crime system for all drug offences recorded for the 2006/7 – current financial years and for all arrests from 19 October 2015 to date.

The information provided in the attached spreadsheets confirm the total number of offences recorded between 1 April 2006 – 19 October 2015 (CIS Offences), the total number of offences recorded between 19 October 2015 – 31 March 2017 (Athena Offences) and the total number of arrests recorded between 19 October 2015 – 31 March 2017 (Athena arrests).



Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
