I write in connection with your request for information received by Suffolk Constabulary on the 11th March, 2018 in which you sought access to the following information:

"Please may I have the total number of knife crimes for the past five 12 month periods?"

Please may I have the most recent 12 months set out like this - from March 2017 to March 2018.

Please may I have the total number of knife crimes for the previous four 12 month periods.

March 2016 - March 2017

March 2015 - March 2016

March 2014 - March 2015

March 2013 - March 2014"

Response to your Request

The response provided below is correct as of 05 April 2018

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary's crime information systems for all violent offences recorded that relate to the possession of a weapon.

The information was then filtered to include those that included the possession of a 'knife', 'Knives', 'Blade', 'Axe', 'Scissors', 'Sword' or 'Machete'.

The below table confirms the total number of offences recorded, confirming the weapon and by the time frame 1 March – 31 February.

*Please note that the 2017-2018 data includes the time range 1 March 2017 – 31 March 2018.

Your Right to Request a Review of Decisions Made Under the Terms of the Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
