

Freedom of Information Request Reference N°: FOI 001635-18

I write in connection with your request for information received by Suffolk Constabulary on the 7 May 2018 in which you sought access to the following information:

“I am writing to make a Freedom of Information request for dog theft data from 2015, 2016 and 2017.

Of the reported theft cases which involved dogs in 2015, 2016 and 2017:

1. *How many led to arrests? Which cases?*
2. *What were the sentencing outcomes?*
3. *How many /which led to custodial sentences, and how long were the sentences?*
4. *How many cases remain unsolved or open?”*

Response to your Request

The response provided below is correct as of 8 May 2018

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s crime system for all theft and burglary offences recorded where ‘Dog’ appears in the property field of the crime.

The total number of offences recorded for the 2015 – 2017 calendar years is provided in the table below, including the respective outcomes. Please note the Constabulary does not hold conviction data, which should be requested directly from the Courts.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
