I write in connection with your request for information received by the Norfolk and Suffolk Constabularies on the 21st May 2018 in which you sought access to the following information:

Please provide figures showing the number of occasions the police were called to attend a newsagents because of a crime that occurred within its premises between 1st April 2017 and 31st March 2018.

Please provide figures showing the number of occasions the police were called to attend a convenience store because of a crime that occurred within its premises between 1st April 2017 and 31st March 2018.
