I write in connection with your request for information received by Suffolk Constabulary on the 21 June 2018 in which you sought access to the following information:

Please indicate the number of times police were called to reports of violence in a crowd at a boxing match/fight night event.

Please give details of reasons for being called out. Was it crowd violence, drunk and disorderly, possessing drugs or offensive weapons?

Please indicate how many people arrested.

Please provide figures for calendar years 2013, 2014, 2015, 2016, 2017, and 2018 so far."

Response to your Request

The response provided below is correct as of 29 June 2018

Suffolk Constabulary has considered your request for information and the response is below.

A search has been conducted via our telephone recording system Storm for all incidents that contain the keywords; **Boxing Match, Fight Night and MMA.**

The below table provides the number and details of incidents retrieved, please note that Suffolk Constabulary introduced a new telephone recording system in November 2013 and therefore any data prior to this date is not available.

There were no relevant calls from 29 November – 31 December 2013 and the whole of 2015.

Please also be advised that none of these incidents resulted in an actual crime being recorded.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
