Freedom of Information Request Reference N^o: FOI 004631/18

I write in connection with your request for information received by the Norfolk and Suffolk Constabularies on the 24th December 2018 in which you sought access to the following information:

- 1 How many people have been charged with murder or manslaughter after a "sex game", "rough sex" or "sexual experiment" went wrong?
- 2 How many charges of attempted murder have been brought after a "sex game", "rough sex" or "sexual experiment" went wrong?
- 3 How many other criminal charges have been brought after a "sex game", "rough sex" or "sexual experiment" went wrong?
- 4 Please provide case notes for all charges brought where "sex" is cited within the crime report as being the cause of the criminal allegation and/or charge and/or cite in an interview in relation to the crime. Please redact any identifying information such as names.

Please provide figures broken down by calendar year for the past three years, 2016, 2017 and 2018.

Response to your Request

Norfolk and Suffolk Constabularies have considered your request and our response is below:-

When responding to a request for information under the terms of the Freedom of Information Act, a public authority is not obliged to provide information if the authority estimates that the cost of the retrieval of the information requested would be in excess of £450 (equivalent to 18 hours work).

The costs criteria relates to a request in its entirety, which means that if we cannot retrieve all of the information requested within the costs limit, we are not obliged to retrieve *any* of the information requested.

The Norfolk and Suffolk Constabularies estimates that to retrieve all the information you have requested for both forces would exceed cost in excess of £450 (per force).

A MO keyword search has been undertaken for recorded crimes where 'sex' is included. This has produced just over 1,000 crime reports per year. Each of these would need to be read through to see if the cause of the offence is sexually motivated.

To review each of these in order to identify any relevant records, based on 5 minutes each, would significantly exceed the appropriate limit for dealing with a Freedom of Information request, in terms of costs, and therefore Section 12(1) of the Freedom of Information Act applies.

Section 12(1) of the Freedom of Information Act states that a public authority is not obliged to:

“...comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit”.

The Freedom of Information (Appropriate Limit and Fees) Regulations 2004, defines the ‘appropriate limit’ for the Norfolk and Suffolk Constabularies as £450 for each Constabulary, and specifies that this sum equates to 18 hours work at a standard rate of £25 per hour.

In accordance with Section 17 of the Freedom of Information Act (2000), this serves as a Refusal Notice for your request.

Advice & Assistance

Although excess cost removes Norfolk and Suffolk Constabularies obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relevant to your request, which was retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

Research has been undertaken of recorded crimes for the following offences using keywords of ‘sex game’, ‘rough sex’ and ‘sexual experiment’:-

- Murder
- Attempted Murder
- Manslaughter
- Attempted Manslaughter

This has produced a nil return.

If you are dissatisfied with the decision made by Norfolk and Suffolk Constabularies under the Freedom of Information Act (2000), regarding access to information, you must notify the Norfolk and Suffolk Constabulary that you are requesting a review within 40 days of the date of its response to your Freedom of Information request.
