I write in connection with your request for information received by Suffolk Constabulary on the 2 January 2019 in which you sought access to the following information:

“The number of incidents you attended involving a mobility scooter in 2017/18.

I am using the term “mobility scooter”. Please take this to include the legal term “invalid carriage”.

Response to your Request

The response provided below is correct as of 10 January 2019

Suffolk Constabulary has considered your request for information and the response is below.

The Constabulary has completed a freetext search of the call system for all incidents that contain the phrases ‘Mobility scooter’ or ‘Invalid carriage’

A total of 58 incidents were located during the 2017/18 financial year relevant to the request. Please note that the information supplied does not clarify the involvement of the mobility scooter in the incident, however the disposal code text for each incident is provided below to assist.

Freedom of Information Act (2000).

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
