Response to your Request

The response provided below is correct as of 14 January 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabularies call and crime systems for all incidents and offences recorded that contain the word ‘Upskirt’ or ‘Upskirting’ for the 2015 - 2018 calendar years. Please note that freetext searches are, by their very nature, unreliable and therefore the offences and incidents provided below rely solely on these specific words appearing within the freetext of the crime or incident summary.
