I write in connection with your request for information received by Suffolk Constabulary on the 8 January 2019 in which you sought access to the following information:

“Could I please receive details of every Sexual Risk order application made to a court since 2013.

Could these please provide details of:

- 1) The reasons the application was made*
- 2) The restrictions on the individual applied for by police*
- 3) If the order was granted by magistrates*
- 4) If the order granted by the court included any amendments to the police application*
- 5) Whether the individual had been convicted of a sexual offence at the time of the application”*

Response to your Request

The response provided below is correct as of 8 January 2019

Suffolk Constabulary has considered your request for information and the response is below.

Suffolk Constabulary has applied 2 Sexual Risk Orders, details of which are as follows:

1. The SRO was applied for in relation to this nominal due to concerns over his behaviour.

He has the following restrictions:

- The defendant is prohibited from using any unisex changing facilities within any premises, which is open to the public.
- The defendant is prohibited from being in possession of any image capturing device within any changing room that is open to the public.

The order was granted by Magistrates with no amendments.

There were no convictions for sexual offences at the time of application.

2. The SRO was applied for due to concerns over his behaviour.

He had the following restrictions:

- The defendant is prohibited from starting and maintaining a relationship with any female under the age of 16 years old without first notifying his Public Protection Officer of her name, date of birth and address.



- The defendant is prohibited from living at an address or residing overnight at an address where a female under the age of 16 years old is present (other than a family member or relative) without first notifying his Public Protection Officer of that address and the name of the person living there.

The order was granted by Magistrates with no amendments.

There were no convictions for sexual offences at the time of application.

Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
