The response provided below is correct as of 28th January 2019.

Norfolk and Suffolk Constabularies have located the following information as relevant to your request.

A review has been undertaken of Police Officers, PCSOs and members of the Special Constabularies who have been subject to court proceedings. The following reflects those cases where the officer or staff member was serving at the time of the offence and were imprisoned as a result of their conviction.

NORFOLK

One police officer was convicted for the offence of Child cruelty and imprisoned. The officer was dismissed following their conviction

One police officer was convicted for the offence of Theft and imprisoned. The officer was dismissed following their conviction.

SUFFOLK

One police officer was convicted of the offence of Pervert the course of justice and imprisoned. The officer was dismissed following their conviction.
