I write in connection with your request for information received by Suffolk Constabulary on the 15 January 2019 in which you sought access to the following information:

“How many crimes have been reported in prisons in the last five years (2018,2017,2016,2015 and 2014), where the synthetic cannabinoid spice or black mamba is mentioned?”

Please can you break this down by year and month, and also detail be given on the nature of the crime (eg there was a disturbance or robbery in which the drug was mentioned. Or the report was due to use of spice in prison)”

Response to your Request

The response provided below is correct as of 23 January 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s crime system for all drug offences recorded relating to synthetic cannabinoid spice or black mamba, where the location is recorded as a prison.

The Constabulary located a total of 12 offences, provided by year and offence. Please note that the search parameters rely on the location being correctly recorded.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
