I write in connection with your request for information received by Suffolk Constabulary on the 21 January 2019 in which you sought access to the following information:

“Under the freedom of information act I would therefore like to know what money has been spent using Section 106 or Community infrastructure Levy funds in Hadleigh or for the benefit of Hadleigh, in the period January 1st 2010-December 31st 2018.”

Response to your Request

The response provided below is correct as of 31 January 2019

Suffolk Constabulary has considered your request for information and the response is below.

No funding has as yet been obtained through the planning process, specifically in relation to Hadleigh.

Where appropriate the Constabulary will seek funding for projects from defined areas through the Community Infrastructure Levy (CIL) process, it therefore may be that funding will be sought for the Hadleigh area from the appropriate Planning Authority in future. There is no defined period for funding applications.

Funding through the planning process is fluid, and the Constabulary will endeavour to liaise with the appropriate planning authority re-funding through the planning process, we will continually check with appropriate parties as to funding that has been realised through the planning process for policing.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
