## Freedom of Information Request Reference N<sup>o</sup>: FOI 000410/19

I write in connection with your request for information received by the Norfolk and Suffolk Constabularies on the 28<sup>th</sup> January 2019 in which you sought access to the following information:

Would you please provide, for each of the years 2012/13 to 2017/18, a combined total for the number of Fixed Penalty Notices and/or Traffic Offence Reports (as applicable) issued for the offence of cycling on a footway (under section 72 of the Highways Act 1835), broken down if possible into sub-totals for:

- fines paid,
- fines/FPNs/TORs cancelled,
- cases referred to Court for prosecution and/or recipients of TORs opted for court proceedings,
- cases disposed of in any other way, and
- cases with resolution still outstanding.

### Response to your Request

The response provided below is correct as of 5<sup>th</sup> February 2019.

Norfolk and Suffolk Constabularies have located the following information as relevant to your request.

No information is held prior to July 2012. Please note fixed penalties were replaced by Traffic Offence Reports in January 2015. If a Fixed Penalty was not paid this would be Fine Registered. If a TOR is unpaid, this results in a prosecution.
