Response to your Request

The response provided below is correct as of 8 March 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s crime system for all offences recorded of ‘Having a Bladed Article on a School Premises’, for the 2012/13 – 2017/18 financial years.

The information has been filtered to include those offences where the suspect was aged under 18 years old, or where the age has not been recorded, noting that this will not necessarily mean the suspect was aged under 18.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
