I write in connection with your request for information received by Norfolk and Suffolk Constabularies on the 13 March 2018 in which you sought access to the following information:

*“Please state how many people have been prosecuted for the theft of a dog or cat in your area over the following time frames: 2016 – 2018 to date”*

### Response to your Request

The response provided below is correct as of 28 March 2018

Norfolk and Suffolk Constabularies have considered your request for information and our response is below.

A search has been completed of the Constabulary's crime system for all offences recorded of 'Theft if not classified elsewhere' and 'Burglary – Domestic', for the 2016 – 2018 calendar years. The information was then filtered to include only those where the words 'cat' or 'dog' appear in the crime text.

The Constabularies do not hold prosecution data and therefore the table below confirms the total number of persons charged with these offences by force and year.

Please note there are some ongoing investigations and other positive outcomes available.
