I write in connection with your request for information received by Suffolk Constabulary on the 8 March 2019 in which you sought access to the following information:

“Please could you provide the number of crimes, broken down by type of crime, recorded by your force in which the suspect was riding a moped / scooter / motor-cycle at the time of the offence, for each of the calendar years 2014, 2015, 2016, 2017 and 2018.

If this information is not readily searchable in your system could you undertake a keyword search for the terms “moped”, “motorcycle”, “motorbike”, “scooter”, “mini moto”, “powered two wheel vehicles” and indicate how many crimes, by the type of crime incidents had these terms recorded.”

Response to your Request

The response provided below is correct as of 20 March 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all offences recorded where the word ‘Moped’ ‘Scooter’ ‘Motor-Cycle’ ‘Motorcycle’ ‘Motorbike’ ‘Mini Moto’ or ‘Powered two wheel vehicle’ appears in the freetext of the crime. Please be aware that freetext searches are by their very nature, unreliable, and consequently the search parameters used will only identify those offences that contain one or more of these specific terms. This will not account for any offences that refer to it as something else, or where the word has been misspelt.

The information provided on the attached table confirms the total number of offences located, by offence and calendar year.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
