Response to your Request

The response provided below is correct as of 12th April, 2018

Norfolk and Suffolk Constabularies have considered your request for information and our response is below.

A review of the internal conduct cases recorded during the period of 22 March 2015 to 21 March 2018 has been conducted to identify those cases where Police Officers, members of police staff and Special Constables have made allegations of harassment against colleagues.

The below tables provide the number of sexual harassment and general harassment cases recorded, detailing Officer Rank or Staff for the person subject to the complaint and the resulting outcome.

In addition, please note that the following:

- Cases relating to sexual harassment have been identified and relate to all incidents of sexual assault, inappropriate touching and comments.
- To identify those cases relating to other forms of harassment this has been based on the wording of the allegation as to whether the person felt the behaviour constituted harassment.
