



## **Freedom of Information Request Reference N°: FOI 001259-19**

I write in connection with your request for information received by Suffolk Constabulary on the 1 April 2019 in which you sought access to the following information:

1. *"Please tell me how many children aged 16 and under were attacked or threatened with a knife in a) 2018 b) 2017 c) 2016 d) 2015 e) 2014 f) 2013*
2. *For the figures for 2018, please tell me how many children were aged ten and under?*
3. *Please tell me how many children aged 16 and under were caught with a knife in a) 2018 b) 2017 c) 2016 d) 2015 e) 2014 f) 2013*
4. *For the figures for 2018, please tell me how many children were aged ten aged ten and under?*
5. *Please tell me how many of the children aged 16 and under caught with a knife in 2018 were either using the knife as a threat or had already used it to harm?"*

### **Response to your Request**

The response provided below is correct as of 18 April 2019

Suffolk Constabulary has considered your request for information and the response is below.

In relation to your request for information and in accordance with Section 17 of the Freedom of Information Act 2000 (FOIA), this response serves as a formal notification of refusal for your request. Suffolk Constabulary does not hold, for the purposes of FOIA, the information you require in a retrievable format.

It is estimated that to attempt to retrieve all of the information you require would take a considerable amount of retrieval time, which would exceed 18 hours. This would exceed the appropriate limit for dealing with Freedom of Information requests, in terms of costs and therefore Section 12(1) of the Freedom of Information Act 2000 applies.

In relation to Question 5 of your request, this would involve an intensive case-read of each investigation to establish if the knife was used physically or as a threat. This would include all Possession of Weapon offences, and in addition Assault offences, taking into account that an offence of Assault with injury involving a knife, may not mean that the victim was actually injured with a knife, i.e. the victim could have been punched. This would involve the manual review of hundreds of cases, and would way exceed the statutory time restraints of the Act.



In addition, to search through these investigations is a subjective question, the harm could be physical or psychological.

Section 12(1) of the Freedom of Information Act 2000 states that a Public Authority is not obliged to: "...*comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.*" The Freedom of Information (Appropriate Limit and Fees) Regulations, defines the 'appropriate limit' for the Suffolk Constabulary as £450 and specifies that this sum equates to 18 hours work at a standard rate of £25 per hour.

In accordance with Section 17(5) of the Freedom of Information Act 2000, this letter serves as a refusal notice for this part of your request.

By requesting *all* information your request is too broad to be complied with within the £450 limit imposed on Freedom of Information requests.

Although excess cost removes the Force's obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

1 and 2

The attached spreadsheet provides details on the "Use of Knife or other Sharp Instrument" offences broken down by year and victims age.

3 and 4

The attached spreadsheet includes all "Possession of Weapons" offences with a keyword of "Use of Knife or other Sharp Instrument, broken down by suspect age.
