I write in connection with your request for information received by Suffolk Constabulary on the 3 April 2019 in which you sought access to the following information:

“The number of sexual offences committed in educational establishments (schools, colleges, universities) in Suffolk from the 1st of January to the 31st December of 2016-2018.

I would like this information broken down into: number of allegations and number of convictions, the specific charge and the level of education, primary, secondary, higher or further.”

Response to your Request

The response provided below is correct as of 11 April 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary's crime system for all sexual offences recorded where the location is a school, college or university. Please be aware that the information provided relates only to those offences where the premise type has been completed as school or college/university. It will therefore not include any relevant offences where this field has not been completed.

Additionally, the location of an offence does not identify whether it occurred within the grounds of the school, college or university, rather that they were the nearest identifiable landmark.

The information provided on the attached spreadsheet confirms the school type, offence title and outcome, by year. The school type, ie primary, secondary etc, is not always recorded on the system and these have been recorded under the generic heading of 'school'. The Constabulary does not hold conviction data, which should be sought directly from the Crown prosecution Service.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
