I write in connection with your request for information received by Suffolk Constabulary on the 6 April 2019 in which you sought access to the following information:

1. *“Number of reported events of stalking?”*
2. *Number of cautions raised for allegations of stalking?*
3. *Numbers of arrests made for allegations of stalking?*
4. *Number of cases referred to the CPS for criminal charges to be brought for stalking?*
5. *Number of cases turned down by the CPS for criminal charges to be brought for stalking?*

I would be grateful, if possible, if you could break your responses down in the following categories:

Gender of victim - male/female

Gender of offender - male/female

Calendar years - 2013, 2014, 2015, 2016, 2017, 2018”

Response to your Request

The response provided below is correct as of 18 April 2019

Suffolk Constabulary has considered your request for information and the response is below.

The Constabularies are unable to confirm the number of occasions an offence was referred to the CPS for prosecution and were rejected or not taken forward by the CPS. This information is not centrally recorded and would only be recorded within the associated crime file. Each would need to be manually reviewed in order to extract this detail, which will involve reviewing the crime report and associated documentation as this type of detail will not necessarily be recorded within the main body of the crime. Considering a search of 4 minutes per offence and that there are 793 relevant offences, would take in excess of 52 hours to extract.

In relation to your request for information and in accordance with Section 17 of the Freedom of Information Act 2000 (FOIA), this response serves as a formal notification of refusal for your request. Suffolk Constabulary does not hold, for the purposes of FOIA, the information you require in a retrievable format.

It is estimated that to attempt to retrieve all of the information you require would take a considerable amount of retrieval time, which would exceed 18 hours. This would exceed the



appropriate limit for dealing with Freedom of Information requests, in terms of costs and therefore Section 12(1) of the Freedom of Information Act 2000 applies.

Section 12(1) of the Freedom of Information Act 2000 states that a Public Authority is not obliged to: "...comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit." The Freedom of Information (Appropriate Limit and Fees) Regulations, defines the 'appropriate limit' for the Suffolk Constabulary as £450 and specifies that this sum equates to 18 hours work at a standard rate of £25 per hour.

In accordance with Section 17(5) of the Freedom of Information Act 2000, this letter serves as a refusal notice for this part of your request.

By requesting *all* information your request is too broad to be complied with within the £450 limit imposed on Freedom of Information requests.

Although excess cost removes the Force's obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

The total number of stalking investigations recorded by the Constabulary is provided within the attached table including the gender of the victims and suspects.

The total number of persons cautioned for stalking offences is provided on the attached spreadsheet by gender of the suspect and victim.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
