I write in connection with your request for information received by Suffolk Constabulary on the 11th April 2018 in which you sought access to the following information:

- 1 How many football-related arrests on women there have been since records for the force began.
- 2 What the outcome of the arrest was in each case - whether it was dropped or if they were charged
- 3 Where the arrest took place in each case.
- 4 If the details are held, how many football banning orders were given out in each case.

Response to your Request

The response provided below is correct as of 13th April 2018.

Suffolk Constabulary has located the following information as relevant to your request.

Research has been undertaken by the Dedicated Football Officer, who has records covering the last 8 years. Please see below results:-

There has been one arrest of a female in 2016. This was at Portman Road and was for Threatening Behaviour Section 4 Public Order Act. An adult caution was issued and the female is subject to an indefinite ban by Ipswich Town Football Club. There was no application for a football banning order.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
