“How many officers took sick leave for depression, anxiety, stress or post-traumatic stress between April 2018 and March 2019. By this, I mean where any of the terms 'depression', 'anxiety' or 'stress' or 'post-traumatic stress' appear in the description of the officer's illness”

The response provided below is correct as of 12th April, 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

The numbers of Officers who took sick leave where any of the terms 'depression', 'anxiety' or 'stress' appear in the description of the officer's illness are as follows.

Norfolk – 162 officers

Suffolk – 153 officers
