I write in connection with your request for information received by Suffolk Constabulary on the 12 April 2019 in which you sought access to the following information:

“How many cases of moped/motorbike-enabled theft (i.e. where belongings have been stolen by a perpetrator on a moped/motorbike) were recorded between 2009 and 2019?”

Response to your Request

The response provided below is correct as of 12 April 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all theft offences recorded where the word ‘Moped’ ‘Scooter’ ‘Motor-Cycle’ ‘Motorcycle’ ‘Motorbike’ ‘Mini Moto’ or ‘Powered two wheel vehicle’ appears in the freetext of the crime. Please be aware that freetext searches are by their very nature, unreliable, and consequently the search parameters used will only identify those offences that contain one or more of these specific terms. This will not account for any offences that refer to it as something else, or where the word has been misspelt.

The information provided on the below table confirms the total number of offences located, by offence and calendar year.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
