I write in connection with your request for information received by Suffolk Constabulary on the 12 April 2019 in which you sought access to the following information:

“The number of religious hate crimes recorded by yourselves by perceived religion over the past ten years.

Please provide the information for each area (ward) you cover. If there are less than five reported offences against a certain religion in an area simply say “less than five”.

Please provide the information for each year since 2009, and provide a total number of reported hate religious crimes for each year.

If information on all the religions is too much, please just focus on reported islamophobic hate crimes.”

Response to your Request

The response provided below is correct as of 25 April 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s current crime system for all hate crimes recorded for the 2009 – 2019 calendar years that have a religion keyword or marker associated to it.

The data provided on the attached spreadsheet confirms all religious hate crimes recorded and the targeted religion. Please note that data identifying specific religion is only available on the current crime system, information held prior to 19 October 2015 is contained within the legacy crime system, which does not contain this level of detail.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
