### **Response to your Request**

The response provided below is correct as of 24 April 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all hate crime recorded where the religion targeted was recorded as Muslim.

The table provided below confirms the total number of hate offences recorded for each date requested and by force, noting that the data excludes non-crimes. This data relates to the date on which the crime was recorded, as opposed to the date the offences was reported to have occurred.
