I write in connection with your request for information received by Suffolk Constabulary on the 25 April 2018 in which you sought access to the following information:

"I request the number of reported robberies of food delivery drivers - including but not limited to Deliveroo and takeaway pizza drivers - driving any vehicle in the calendar years: 2013, 2014, 2015, 2016, 2017, 2018 so far.

I request to know if the victims reported the food they were carrying stolen as well.

I also request the names of defendants involved in any successful convictions."

Response to your Request

The response provided below is correct as of 11 May 2018.

Suffolk Constabulary has considered your request for information and the response is below.

The term 'Delivery driver' is not an occupation recorded within the crime system. Therefore a search has been completed of the words #delivery' and 'takeaway' in the freetext of the crime report to establish whether any of those reference robberies from delivery drivers.

The table provided below confirms the total number of offences located using the above search terms, that are specifically relevant to this request. All offences located occurred in 2016.

Suffolk Constabulary does not hold conviction data, which is held by the Courts. We have therefore provided the recorded outcome for each offence.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
