I write in connection with your request for information received by Suffolk Constabulary on the 3 May 2019 in which you sought access to the following information:

*“Could you please tell me the number of hate crimes recorded at schools and colleges in each calendar year for the past 5 years, broken down by month? I appreciate that the 2019 year is not yet complete, but even partial data for this year would be acceptable.*

*And could you also provide a breakdown of the description of the hate crime (race, sexuality etc) for each year?”*

**Response to your Request**

The response provided below is correct as of 9 May 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s crime system for all hate crimes recorded where the location was recorded as either a school or college/university. Please note that the location description is a non-mandatory field and consequently, there may be additional relevant offences that have not been identified from this search.

The tables provided below confirm the total number of hate crimes recorded as occurring at schools, for the years requested.

Your Right to Request a Review of Decisions Made Under the Terms of the  
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
