



## Freedom of Information Request Reference N<sup>o</sup>: FOI 001689-19

I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 3 May 2019 which you sought access to the following information:

*“Please can you provide the number of reported thefts of motorcycles and scooters in the Suffolk and Norfolk police force area for the periods 1st January – 31st December 2017 and 1st January – 31st December 2018.”*

### Response to your Request

The response provided below is correct as of 21.05.2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been carried out of the Constabularies crime information systems for all Theft of Motor Vehicle and Aggravated Vehicle Taking offences recorded, where the property stolen has been identified as either a motorcycle or scooter.

The below table is broken down by the times periods specified.

Force	Type	2017	2018
Norfolk Constabulary	Motorcycle	75	66
