I write in connection with your request for information received by Suffolk Constabulary on the 29 May 2019 in which you sought access to the following information:

“Could you please give me a complete list of all items stolen from police stations and vehicles since the beginning of 2015?”

Could you also provide me with the value of each item stolen and the location from which it was taken?”

Response to your Request

The response provided below is correct as of 17 June 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all theft offences recorded where the premise type is recorded as 'Ambulance Station / Fire Station / Police Station' or where the victim is recorded as 'Police'. Each offence was then manually reviewed to extract those that related to thefts from Norfolk and Suffolk Constabulary buildings or vehicles.

Based on the above search parameters, no offences were located as relevant to the request.

Please note that there may be additional relevant offences that have not been located using this search owing to the premise type or victim details not being entered into the correct field.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
