Please can you detail the number of crime reports mentioning "Xbox Live" and "Fortnite" over the last four calendar years (2016, 2017, 2018 and 2019 so far)? Please break this down by year and include details of the nature of the offence (eg Sexual Grooming/ Malicious Communications/ Harassment).

Response to your Request
