I write in connection with your request for information received by Suffolk Constabulary on the 11 June 2018 in which you sought access to the following information:

1. *"I have search through the Blue Lights Portal (<https://www.blpd.gov.uk/foi>) and could not find the Telefonica contract, I did see you have a contract for Nu Technologies. Could you confirm if the Nu Technologies contract has replaced the Telefonica contract?"*
2. *If the Nu Technologies is now the supplier could you please send me the following:*
 - a. *The approximate annual spend?*
 - b. *The number of users?*
 - c. *The framework Reference number?"*

Response to your Request

The response provided below is correct as of 2 July 2018

Suffolk Constabulary has considered your request for information and the response is below.

The Constabulary now has a contract with Insight, which can be found on the Blue Light Procurement Database (BLPD) under reference 2018-002, which includes the annual expenditure and framework reference number.

Section 17 of the Freedom of Information Act 2000 requires that Suffolk Constabulary, when refusing to provide such information (because the information is exempt) is to provide you the applicant with a notice ban which:

- (a) States that fact
- (b) Specifies the exemption(s) in question and
- (c) States (if that would not otherwise be apparent) why the exemption(s) applies.

The information is exempt from disclosure by virtue of the following exemption(s);

Section 21(1) - Information reasonably accessible by other means

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
