I write in connection with your request for information received by Suffolk Constabulary on the 18 June 2018 in which you sought access to the following information:

“Could I please request any and all information you hold on the national police uniform (or what name it now holds) and whether the Police in England and Wales have a minimum Personal Safety Equipment uniform which each officer requires including footwear. If possible with guidance as to compliance with Health and Safety legislation and the HSE Executive.”

Response to your Request

The response provided below is correct as of 2 July 2018

Suffolk Constabulary has considered your request for information and the response is below.

Suffolk Constabulary does not hold any information in relation to a National Police Uniform, there is no formal requirement or list that stipulates what can and cannot be worn by the Home Office.

The Home Office does mandate that body armour meets a certain criteria, and the below link will direct you to the “Home Office Body Armour Standard (2017)”.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
