I would like this information for each of the financial years 2016/17, 2017/18 and 2018/19”

The response provided below is correct as of 26 June 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary's call data for all incidents recorded that contain the word 'crossbow' or 'cross bow'.

The information provided on the attached spreadsheet confirms the year and month of the offence, the disposal code text, a summary of the incident and whether any subsequent offences was recorded, including what that offence was.

Please note that any calls recorded where crossbow appears in the address field or where the word is not associated with the specific incident, have been removed.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
