As of 18.06.2019 How many police officers are suspended from duty within your force as a result of on going criminal and/or disciplinary proceedings and/or investigation

Response to your Request

The response provided below is correct as of 2nd July 2019.

Norfolk and Suffolk Constabularies have located the following information as relevant to your request.

Research has been undertaken regarding Police Officers suspended from duty or on restricted duties as at 18th June 2019. Please see below:-

NORFOLK

As at 18th June 2019, four Police Officers were on restricted duties whilst under investigation by the Professional Standards Department.

Three of the officers are under investigation in relation to criminal offences, however, no decision has been made regarding whether any of the officers will be charged.

No officers were subject to suspension as at 18th June 2019.

SUFFOLK

As at 18th June 2019, five Police Officers were on restricted duties whilst under investigation by the Professional Standards Department.

The five officers are under investigation in relation to criminal offences, however, no decision has been made regarding whether any of the officers will be charged.

No officers were subject to suspension as at 18th June 2019.
