I write in connection with your request for information received by the Norfolk and Suffolk Constabularies on the 9th July 2018 in which you sought access to the following information:

The projected costs of maintenance of the police estate over the next decade, broken down with estimate costs where possible.

Response to your Request

The response provided below is correct as of 16th July 2017.

Norfolk and Suffolk Constabularies have located the following information as relevant to your request.

Projected costs of maintenance for the next decade are not held. We have provided below the figures for the baseline estates revenue budgets for the current financial year.
