I write in connection with your request for information received by Suffolk Constabulary on the 12 July 2019 in which you sought access to the following information:

1. *“How many domestic violence offences has your force recorded where the suspected perpetrator was identified as male in the last ten years? Please break this down by calendar year.*
2. *Can I also ask how many domestic violence offences have you recorded in the last ten years where the victim was male? Please can this also be broken down by calendar year.”*

Response to your Request

The response provided below is correct as of 29 July 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary's crime system for all domestic related offences recorded where the suspect or victims' gender was recorded as male.

Please note that the crime system does not record offences under domestic violence categories, rather the data supplied falls under domestic abuse.

The total number of offences recorded where the victim or suspect gender is male, is provided in the table below:

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
