I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 1 August 2019 which you sought access to the following information:

“Please tell me how many crime reports in 2018 were made about people stealing wild birds (swans, sparrows, magpies, ducks, pigeons, herons, seagulls, etc.)?”

Please provide me with the MO codes/crime details for the first 10 incidents from 2018.”

Response to your Request

The response provided below is correct as of 15 August 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all theft offences recorded for the 2018 calendar year, that contain one or more of the following words: 'wild bird' 'bird' 'swan' 'sparrow' 'magpie' 'duck' 'pigeon' 'heron' 'seagull'. Please note that free text searches are by their very nature, unreliable and consequently there may be other relevant offences recorded that have not been picked up by the search parameters used.

The Constabularies located two results as follows:

Force	Year	Animal Type	M.O. Description
Suffolk	2018	Seagull	Children have taken four baby gulls from the nest.
Norfolk	2018	Geese	Persons unknown have stolen 10 to 40 geese from the farm land

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.
