I write in connection with your request for information received by Suffolk Constabulary on the 5 August 2019 in which you sought access to the following information:

“The number of persons arrested at Latitude 2019 each day with a breakdown of offence;

Of the number of persons arrested, the number that were charged with the offence, charged and released on bailed, and released with no further police action.”

Response to your Request

The response provided below is correct as of 27 August 2019

Suffolk Constabulary has considered your request for information and the response is below.

The Constabulary has completed a search of arrest data with a location of Henham or Latitude. Each return was reviewed to ensure it related to an arrest at Latitude itself.

The Constabulary located a total of 18 arrest records that occurred on the dates of the festival, the details for which are in the table below. Please note that any arrests made after the festival will not be included within the return.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.
