I write in connection with your request for information received by Suffolk Constabulary on the 5 September 2019 in which you sought access to the following information:

“Basic accident information on fatal and serious road accidents in the last 7 years along the A137 in Tattingsstone, Suffolk (information to include number of accidents, number of vehicles involved, the cause of accident e.g speed, injury or fatality).”

Response to your Request

The response provided below is correct as of 6 September 2019.

Suffolk Constabulary has considered your request for information and the response is below.

The information provided below confirms the total number of Road Traffic Collisions (RTCs) recorded by the Constabulary, along the A137 Tattingsstone over the last 7 years.

Date	Details
26/02/2014	Serious accident involving 1 vehicle. Vehicle has overtaken a vehicle, and a motorcycle has then overtaken V1. V1 has lost control and left the road. Contributory factor: Loss of control
05/09/2016	Serious accident involving 2 vehicles. Vehicle veered into the opposite lane and collided with vehicle traveling in the opposite direction Contributory factor: Slippery Road.
30/09/2017	Serious accident involving 2 vehicles. Vehicle has overtaken on the approach to a junction as another vehicle has pulled out of the junction. Contributory factor: Failed to look properly.
22/05/2019	Serious accident involving 2 vehicles. Vehicle has been crossing the road into a driveway when other vehicle has been travelling in the opposite direction at speed and collided into the rear of the other. Contributory factors: Failed to look properly, Exceeding speed limit, Poor turn or manoeuvre.
12/09/2019	Serious accident involving 3 vehicles. Vehicle has lost control, left the carriageway and collided with a parked vehicle, hedge and electricity pole and another parked vehicle.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
