



## Freedom of Information Request Reference N°: FOI 003219-19

I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 6 September 2019 which you sought access to the following information:

- 1. "The number of crimes that occurred in the month of December 2018 that include the word "Christmas" in the MO or offence description. (Please make sure that this includes phrases like "Christmas tree" and "Father Christmas".)
- 2. The number of crimes that occurred in the month of December that include the phrase "Santa Clause" in the MO or offence description.
- 3. For both of the above, please provide me with as much of the MO or offence description as possible."

### Response to your Request

The response provided below is correct as of 19 September 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all offences recorded where the word 'Christmas' or 'Santa' appear in the freetext of the crime report.

The information provided in the table below confirms all offences recorded during December 2018.

Santa Claus	0	0
Santa	3	1

Additional information is provided within the attached spreadsheet and includes the offence description and summary of the offence.

Please note that freetext searches are by there very nature unreliable and consequently, there may be additional relevant offences that have not been included within the return as the words were spelt incorrectly etc.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

# Your Right to Request a Review of Decisions Made Under the Terms of the Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask the Norfolk and Suffolk Constabulary to review their decision.

## Ask Norfolk and Suffolk Constabularies to look at the decision again.

If you are dissatisfied with the decision made by Norfolk and Suffolk Constabularies under the Freedom of Information Act (2000), regarding access to information, you must notify the Norfolk and Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
