“Please can you tell me how many girls/women have been arrested for assisting an offender in the calendar years 2016, 2017 and 2018 broken down by age?”

Response to your Request

The response provided below is correct as of 24 September 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all arrests recorded for assisting an offender and the suspect was female.

The tables provided below confirm the total number of offences of assisting an offender recorded where the person arrested was female, broken down by year, summary and suspects age and provided by Constabulary.
