



## **Freedom of Information Request Reference N°: FOI 003330-19**

I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 16 September 2019 which you sought access to the following information:

*“Please can you provide me (as FOI request) with data regarding the number of crimes and respective outcomes and confiscations, related to riding e-scooters for each calendar month in 2019.*

*Can you also give me the data from 16th July to 16th August 2019?”*

### **Response to your Request**

The response provided below is correct as of 3 October 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

The Constabularies have completed a freetext search of the crime system for all offences that contain the word ‘e-scooter’ during the 2019 calendar year to date.

There was one offence recorded of ‘Section 5 POA Harassment, alarm, distress’ recorded in February 2019 in Suffolk, which has an outcome of ‘Type 14 – Evidential difficulties Victim based – Suspect not identified’.

A search of the Constabularies property database located one child’s scooter, which was seized in May 2019 in Norfolk as a result of insurance offences under Section 165a of the Road Traffic Act 1988.
