I write in connection with your request for information received by Suffolk Constabulary on 21 October 2018 in which you sought access to the following information:

1. *"How many offences concerning violence against the person has your force recorded where the key term "Conservative" or "Tory" or "Tories" has been used? (ie where the terms has been mentioned in the MO field of a crime report)? In 2012? 2013? 2014? 2015? 2016?"*
2. *How many offences offence concerning violence against the person has your force recorded where the key term "Liberal Democrat" or "Lib Dem" has been used? (ie where the terms has been mentioned in the MO field of a crime report)? In 2012? 2013? 2014? In 2015? In 2016?"*
3. *How many offences offence concerning violence against the person has your force has recorded where the key term "Labour" has been used? (ie where the term has been mentioned in the MO field of a crime report)? In 2012? 2013? 2014? In 2015? In 2016?"*

Response to your Request

The response provided below is correct as of 28 October 2018

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary's crime system for all violent against the person offences recorded, which contain the one or more of the following words: 'Conservative', 'Tory', 'Tories', 'Liberal Democrat', 'Lib Dem', 'Labour'.

The Constabulary located one offence relevant to the request, as follows:

Year	Type	Political party
2015	Violence against a person/Violence without injury	Conservative

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
