I write in connection with your request for information received by Suffolk Constabulary on the 3 October 2019 in which you sought access to the following information:

"1. How many incidents of assaults on a HGV driver were recorded in the last 5 years - from 2015 up until 1st October 2019?

a) Please can I have the data broken down year by year, (i.e sequentially 2015, 2016, etc)

2) In each incident please state the type of assault (whether it was verbal or physical)?

3) In each incident please state whether a weapon was used, and if so what it was?

Response to your Request

The response provided below is correct as of 11 October 2019

Suffolk Constabulary has considered your request for information and the response is below.

A freetext search has been completed of the Constabulary's crime system for all offences recorded that contain the term 'HGV'. The table provided below confirms the number of reported assaults on HGV drivers broken down by years. There were no weapons used in any of these assaults.

Please note that the information provided is based on a freetext search, which is not considered entirely accurate in nature. Therefore there may be additional relevant offences not provided within the response as the term HGV was not specifically recorded within the crime text.

Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
