GLOSSARY OF TERMS

- **BRC** – BACK RECORD CONVERSION – PROCESS FOR REPLICATING SIS II ALERTS ONTO I-24/7
- **BRC RATE** – PERCENTAGE OF SIS II ALERTS CONVERTED TO INTERPOL DIFFUSION (N.B. NOT ALWAYS A LIKE-FOR-LIKE TRANSLATION)
- **EAW** – EUROPEAN ARREST WARRANT
- **FNO** – FOREIGN NATIONAL OFFENDER
- **I-24/7** – DATABASE ADMINISTERED BY INTERPOL TO FACILITATE SHARING OF POLICE INFORMATION
- **ILO** – INTERNATIONAL LIAISON OFFICER
- **ITAC** – INTERNATIONAL TACTICAL ADVISOR
- **SIS II** – SCHENGEN INFORMATION SYSTEM (VERSION 2) – MECHANISM FOR SHARING POLICE INFORMATION ACROSS EU AND SCHENGEN STATES.
- **UK ICB** – UK INTERNATIONAL CRIME BUREAU, A NATIONAL FUNCTION WITHIN THE NATIONAL CRIME AGENCY

SUMMARY OF SCHENGEN INFORMATION SYSTEM ALERTS & INTERPOL NOTICE TYPES

Types of SIS II Article and purpose

Persons wanted for arrest (Article 26) this alert category covers persons for whom a European Arrest Warrant or Extradition Request (Associated Countries) has been issued.

Missing persons (Article 32) the purpose of this alert category is to find missing persons, including children, and to place them under protection if lawful and necessary.

Persons sought to assist with a judicial procedure (Article 34) the purpose of this alert category is to find out the place of residence or domicile of persons sought to assist with criminal judicial procedures (for example witnesses).

Persons and objects for discreet checks (Article 36) the purpose of this alert is to obtain information on persons or related objects for the purposes of prosecuting criminal offences and for the prevention of threats to public or national security.

Objects for seizure or use as evidence in criminal procedures (Article 38) this alert covers objects (for example vehicles, travel documents, credit cards, number plates and industrial equipment) being sought for the purposes of seizure or use as evidence in criminal proceedings.

Types of Notice



Red Notice
To seek the location and arrest of wanted persons with a view to extradition or similar lawful action.



Blue Notice
To collect additional information about a person's identity, location or activities in relation to a crime.



Green Notice
To provide warnings and intelligence about persons who have committed criminal offences and are likely to repeat these crimes in other countries.



INTERPOL-United Nations Security Council Special Notice
Issued for groups and individuals who are the targets of UN Security Council Sanctions Committees



Yellow Notice
To help locate missing persons, often minors, or to help identify persons who are unable to identify themselves.



Black Notice
To seek information on unidentified bodies



Orange Notice
To warn of an event, a person, an object or a process representing a serious and imminent threat to public safety



Purple Notice
To seek or provide information on modus operandi, objects, devices and concealment methods used by criminals
