I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 21st October, 2019 which you sought access to the following information:

“In the six months between April 12 2019 and October 11 2019 (or the nearest date to this point for which data is available), please could you tell me the number of allegations of upskirting reported to police?”

Upskirting was made a specific offence under the Voyeurism Act, and came into force on April 12 2019.

Where possible, please break down the date of when the incident was alleged (month is fine).

Where possible, please state the details of allegation (basic details such as what is alleged to have happened, the age and sex of the alleged victim, where known).

Where possible, please state whether the allegation ever formed some part of a criminal charge (and, where possible, details of any prosecution).”

Response to your Request

The response provided below is correct as of 22nd October, 2019

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been carried out of the Constabularies crime system for all offences recorded under ‘Additional Voyeurism Offences (upskirting)’ between 12th April 2019 – 11th October 2019.

There was a total of two offences located, which are detailed below:
