I write in connection with your request for information received by the Norfolk and Suffolk Constabularies on the 16<sup>th</sup> October 2018 in which you sought access to the following information:

I would like to know please the number of licenced firearms reported stolen in each of the following years, with details of the incidents in which they were stolen eg two shotguns stolen in one burglary.

- 2018/19 up to October 16 2018
- 2017/18
- 2016/17
- 2015/16

If possible, and if it fits within the cost/time limit, I would also like to know the number of weapons subsequently recovered.
